Introduction

Integral Skills is a Registered Training Organisation (RTO number 45528) registered with the Australian Skills Quality Authority. Integral Skills is proud to offer training in, RIIHAN301E Operate elevating work platform.

It is recognised and accepted throughout Australia. Please be aware that the “Yellow Cards” are issued by an industry body outside the VET system. You do not require a Yellow Card to operate an EWP or scissor lift. This is a common misconception.

Course Description

This course provides learners with the skills and knowledge required to safely operate an EWP (Scissor Lift).

Learners will understand how to conduct a pre-use check, learn about safety aspects required in operating a Scissor Lift. The training will include sufficient time to allow learners to practice their skills on a Scissor Lift prior to their assessment.

This course is essential for people working in Warehousing, Logistics or those who are required to operate a Scissor Lift as part duties with the workplace (i.e. construction, roofing, plasters, bricklayers etc).

Mode of Delivery

Delivery of this course will be trainer led and delivered over one day of face-to-face training in a classroom setting combined with skills practice and assessment in a simulated workplace. Depending on course numbers and learners pre-existing knowledge, the duration may be reduced.

Clothing Requirement

Learners must wear enclosed shoes or work boots and suitable clothing (i.e. no singlets). Where a learner is not attired appropriately, they will not be able to participate in the course due to work health and safety concerns.

Assessment Summary

The assessment requires the learner to complete a written knowledge assessment and then demonstrate their applied knowledge and skills during a practical assessment operating a Scissor Lift while being observed by the assessor.

The learner must answer all the written knowledge questions correctly. There is the opportunity for this knowledge assessment to be conducted verbally if the learner requires this level of support, but prior notice must be given to allow appropriate arrangements to be made.

The practical assessment is conducted under controlled conditions in a simulated workplace. The assessment will involve carrying out pre and post start-up checks, completing risk assessment, operating the Scissor Lift whilst performing a range of tasks and monitoring workplace hazards and communicating with others in the workplace.

National recognition

On successfully completing the training and assessment you will be issued a Statement of Attainment for the before mentioned unit of competency.

The unit of competency is nationally recognised and provides individuals with a valuable outcome that is recognised throughout Australia.

Course Materials

Learner training is supported through the provision of quality learning materials and resources. Learners should attend the course in comfortable appropriate work clothing. All equipment and consumables are supplied as part of the course.

Pre-Requisites/Entry Requirements

- There are no pre-requisites for this course identified within the industry training package. Integral Skills do require learners to meet the following local entry requirements:
- Learners must be aged 15 years or older.
- Language, literacy and numeracy skills required to interpret work instructions, equipment operating instructions.
- Learners should be dressed as previously explained.
- Learners must be alert and physically capable of performing practical tasks. If there is any doubt please contact us prior to booking.
